ORDER BY THE GOVERNOR
NOTIFICATION

Dated: Shillong, the 24th January, 2025.

No.LE&SD.31/2020/240 - In exercise of the powers conferred under Section 40 and Section 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act 27 of 1996), the Governor of Meghalaya is pleased to further amend the Meghalaya Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008 (hereinafter called the principal Rules), namely:

1. Short title and commencement:- (1) These Rules may be called the Meghalaya Building and Other Construction Workers (Regulation of Employment and Conditions of Service) (Amendment) Rules, 2025.

(2) They shall come into force from the date of notification in Official Gazette.

Amendment of Rule 277:

In Rule 277 and sub-rule (1) of Rule 277, of the Principal Rules, for the existing words and figures “₹3000 (Rupees three thousand)” appearing therein, the words and figures “₹10,000/- (Rupees Ten thousand)” shall be substituted.

Amendment of Rule 279: In Rule 279 of the Principal Rules, for the existing words and figures in sub-rule (5), “₹1000 (Rupees One thousand) only per mensem” shall be substituted by the words and figures “₹1500 (Rupees One thousand Five hundred) only per mensem”.

Amendment of Rule 281: In Rule 281 of the Principal Rules, for the existing figures and words “₹1000 (Rupees One thousand) only” shall be substituted by the figures and words “₹1500 (Rupees One thousand Five hundred) only” per mensem.

Amendment of Rule 287: In Rule 287 of the Principal Rules, for the existing words and figures. “₹200 for the first five days and ₹100 each for the remaining days subject to a maximum ₹5000” appearing therein, shall be substituted by the words and figures “₹400 (Rupees Four hundred) per day for the first five days and ₹200 (Rupees Two hundred) each for the remaining days subject to a maximum of ₹10,000 (Rupees Ten thousand)”.

2. Insertion of Rule 287 A: After the existing Rule 287 of the Principal Rules, a new Rule 287 A shall be inserted as follows, namely:

“287A Medical Camps – Medical Camps are to be conducted at a maximum rate of ₹65,000/- (Rupees Sixty Five thousand) per Camp.”

Amendment of Rule 289: In Rule 289 of the Principal Rules, for the existing figures and words “₹5000 (Rupees Five thousand) only” shall be substituted by the figures and words “₹ 8000 (Rupees Eight thousand) only” of all adult children of a beneficiary subject to production of proper documentation such as Marriage Certificate, etc.

3. **Amendment of Rule 290.** – (i) In Rule 290 of the principal Rule for the existing words “ In the event of death of pensioner family pension shall be given to the surviving spouse” will be substituted by “In the event of death of pensioner family pension will be extended to the surviving spouse of a late beneficiary who has attained the age of 60 years and drawing Welfare Pension from the Meghalaya Building & Other Construction Workers’ Welfare Board. It shall also be extended to the surviving spouse of an active beneficiary who is yet attain the age of 60 years.”

(ii) In Rule 290 of the principal Rules for the existing figures & words “₹500 (rupees Five hundred) only shall be substituted by the figures and words “₹750 (Rupees Seven hundred and Fifty) only”

(iii) In Rule 290 of the principal Rules, Wherever the words “pensioner” occurs the words “beneficiary or pensioner” shall be substituted.

4. Amendment of Regulations governing the award of Scholarship:

In the existing sub-clause (i) under Clause VI-Value of Scholarship of the Regulations, the MBOCWWB is introducing Educational Scholarship, over and above the existing Book Grant and Uniform Grant, @ of ₹ 600 per annum for Classes I –II and @ ₹ 900 per annum for Classes III –IV.
